Many years of experience in logistics and specially trained staff mean that we can also deal with detailed tasks such as applying labels, assembling product sets and packaging products for shipping. We are in the process of building our own integrated transportation and delivery network in areas such as the Greater Tokyo and Kansai areas, utilizing major transportation routes between the Kanto, Kansai and Kyushu regions.

In addition to the Medical Device Manufacturer, Retail/ Rental License of Specially Controlled Medical Device licenses, we are the first in the warehousing industry to have Medical Device Repair licenses in all categories. Therefore, one of our major strengths is our ability to provide one-stop solutions from shipping and receiving of medical equipment to maintenance, cleaning, and repairs.

International marine shipping

We perform development according to customer needs, primarily in the Tokyo and Yokohama regions, and provide comfortable spaces, such as office buildings and residential buildings.

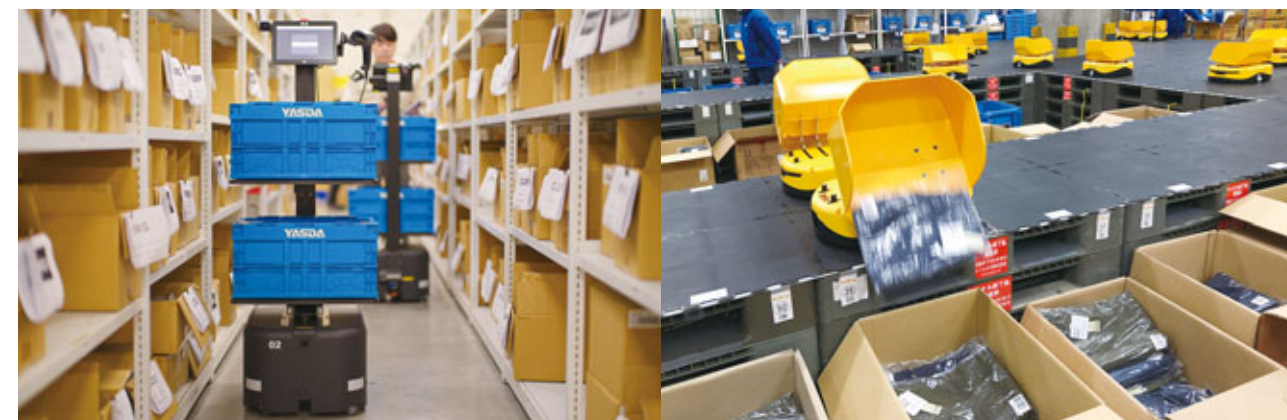

We are developing office and condominium buildings mainly in Tokyo and Yokohama, and we redevelop real estate when necessary, intending to maintain harmony with the surrounding urban environment.
